1. All information disclosed by The South Devon Players Theatre & Film Company and/or those individuals or organizations working in collaboration with The South Devon Players Theatre & Film Company, written, electronic or oral, that relates or refers directly or indirectly, to the Project including the script itself, images, video, internal communications, social media, music, shall hereafter and forever be deemed confidential and shall constitute Confidential Information.
2. The Confidential Information shall remain the property of the The South Devon Players Theatre & Film Company and shall not be disclosed or revealed to anyone except to The South Devon Players Theatre & Film Company, and its formally contracted agents, licensees, successors and assigns. The undersigned shall be responsible for any improper disclosure of Confidential Information
3. This confidential information includes, but is not limited to, scripts, amendments of scripts, video or motion picture footage, still images, musical soundtracks, production information, release dates, cast & crew conversations or internal communications, internal operations, technical designs, technical effects, selfies, images. designs of costumes or props and any personal information as defined under the Data Protection Act.
4. Should the undersigned have a reason to request use, release or dissemination of script, footage, images, derivative work, or other data, this request shall be made formally in writing to the production company, and agreed, or declined, in writing by both the author (if relevant) and the registered directors of The South Devon Players Theatre & Film Company.
5. This above described information and data remains the property of The South Devon Players Theatre & Film Company. All original work by a script/ screenwriter from which dramatic productions have been derived; Eg scripts, is to be solely credited to the named author, and to The South Devon Players Theatre & Film Company for production, and is solely licensed to be produced under that production company name. It is prohibited to release the work or derivatives under an alternate production or company name without a formally written agreement.
6. This agreement in no way guarantees, or suggests, that the undersigned will be employed, or compensated for time or expenses as it pertains to the development and evaluation of the Project. Should there be an alternate arrangement, this will be agreed in a separate contract.
7. All cast and crew will be formally provided, by the end of the performance, or at the release of the motion picture, at latest, with watermarked character photos, production stills and video clips for use solely in their personal portfolio, with full credit to The South Devon Players Theatre & Film Company, as a full title ("SDP" as a credit is not acceptable).
8. Should any provision of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable.
